1. This document is to serve as a contractual between the parties and in consideration of their mutual promises and is considered legally binding

3. Payment in full is due ___ week(s) prior to shipping or pick up of puppy. No puppy shall leave our premises until payment has been received in full. All travel expenses shall be the buyer's responsibility, including crate, health certificate and airplane,

4. ***TitanBull will schedule all departures and arrangements as to ease the transportation demands on sellers. No new owners are allowed to arrange for flights and or purchase tickets, crates, etc. As TitanBull must abide by certain rules and regulations of the airlines.***

5. Puppy shall arrive with health certificate to include current vaccination record at approximated ___ weeks of age. TitanBull will micro-chip said puppy.

6. Puppy shall have a health guarantee for two years against congenital birth defects such as heart, lung, kidney, liver disease, etc. If puppy is diagnosed with congenital birth defect (confirmed by two or more veterinarians) within the first two years of life, He must be sterilized or put down. A replacement puppy of equal or great value would be offered.

7. TitanBull will not be responsible for any veterinarian bills this is to include meds, labs, x-rays, etc.

8. Buyer is responsible for the care and upkeep of puppy. TitanBull is not responsible for illness or death caused by neglect and or poor immunization practices and or improper dietary regimes.

9. TitanBull will not sell to PUPPY MILLS. Buyers agrees to be acting in this purchase for themselves and not as an agent for another party or entity.

10. Buyer agrees to provide with veterinarian care to include all required immunizations, a fenced area in the yard for exercise. Puppy or adult at no time shall be sheltered as an outside dog. Buyer assumes that said puppy shall be raised in the home with the proper bedding, provisions of water and prescribed diet.

11. Seller recommends that said puppy be well socialized and attend obedience training. TitanBull shall not be hold responsible for inappropriate training or care. Puppy is not to be trained as an attack and or fighting dog. Buyer shall be accountable to the extent of the law, in the event of afore mentioning training methods and in addition will be liable for any abuse inflicted on puppy.

12. Bullmastiff shall not be subjected to teasing or abusive handling, Should at anytime this puppy or adult is mistreated, neglected, and or abuse by the buyer or anyone in the buyers household, the sellers (TitanBull) reserved the right to remove said puppy or Adult for the buyer and assume immediate possession. There will be no reimbursement to buyer, whom may be held accountable to all criminal charges.

13. In the event of litigation, all legal fees will be separated between the parties in equal shares. Any dispute over part and or whole of this agreement shall be disputed in the district in which the sellers reside.

14. Puppy shall be examined by the buyer's veterinarian within 48 hours of physical custody. If puppy is not in good health, the buyer shall return it to TitanBull by the 3rd day of purchase (with registration and health certificate) and the buyer will receive a full refund. A failure by the buyer to have puppy checked by a veterinarian within the 48 hours period, the guarantee herein stated will be void. Seller shall not be responsible for puppy if he/she acquires Parvo and or any other infectious disease after buyer has had physical custody for 7 days.

15. TitanBull acknowledges that this puppy is to be sold non breeding. TitanBull will never knowingly breed and or sell puppies that have known genetic or congenital flaws. TitanBull cannot guarantee that said puppy will win in show arena and or finish championship. Or that with maturation a "show flaw" may present, such "flaw" would be considered cosmetic and are not perceived as a defect.

16. TitanBull maintain the right to use pictures of said puppies as well as share information regarding the same, in text as well as for use on website, and or any articles published.
